White Pine County, et al., by and through the undersigned counsel, hereby join in the *Motion to Dismiss for Failure to Join United States Department of Interior Bureaus* filed by the Confederated Tribes of the Goshute Reservation, Ely Shoshone Tribe, and Duckwater Shoshone Tribe. For the reasons stated therein, and because White Pine County, et al., share many of the Tribes' interests in ensuring that any 3M plan be objectively robust and enforceable, and be developed with full, open participation of the United States Department of the Interior ("U.S. DOI") Bureaus, White Pine County, et al., join the Tribes in requesting that this Matter be dismissed for failure to join the U.S. DOI Bureaus. In the alternative, the hearing on remand for these applications should be stayed until the U.S. DOI Bureaus are properly joined.
